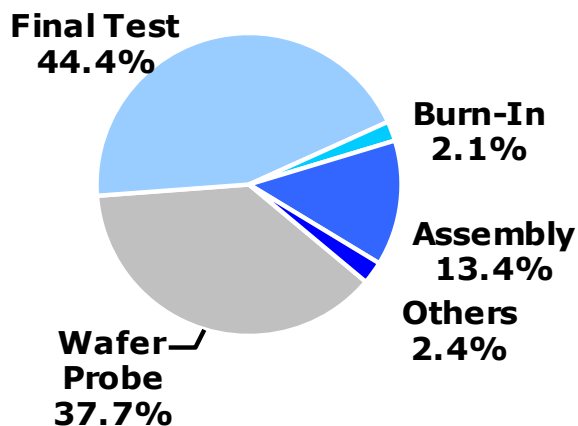

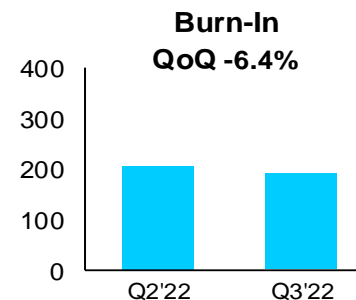
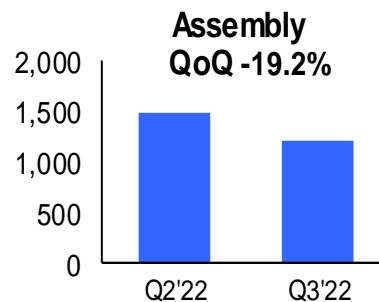
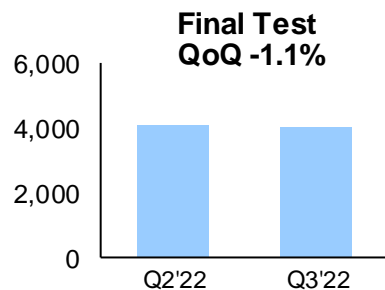
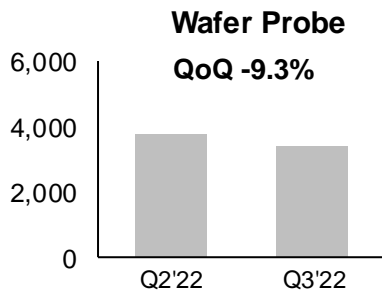
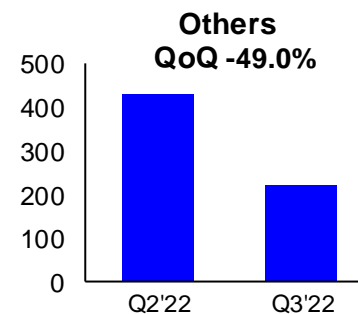


# Q3'22 Revenue Breakdown By Process (unaudited)

## By Process



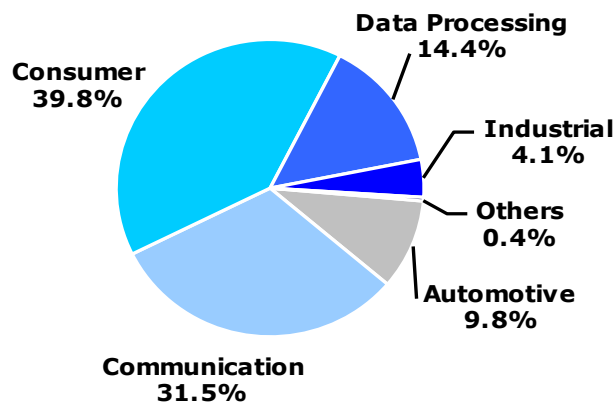

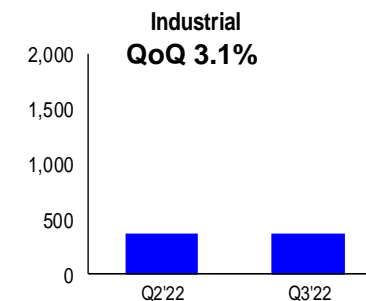
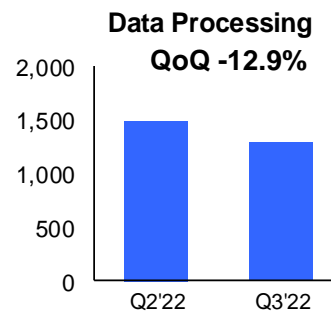
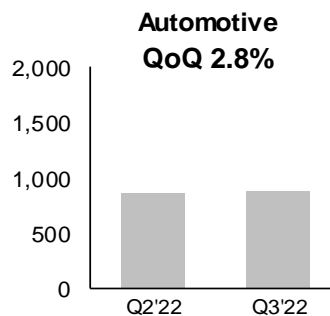
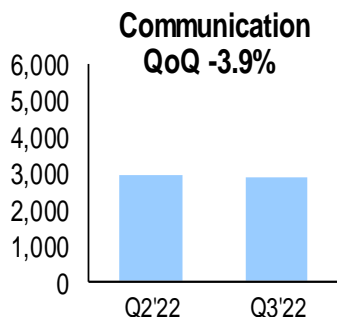
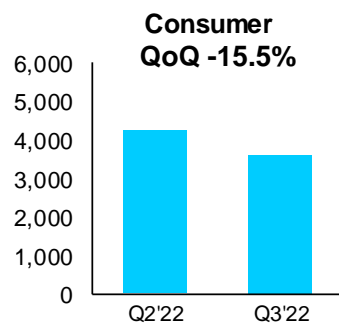
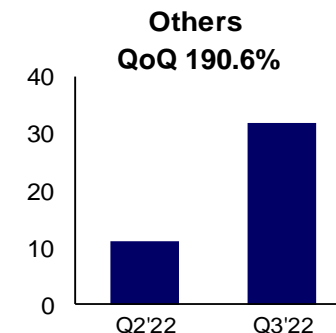


# Q3'22 Revenue Breakdown By Applications (unaudited)

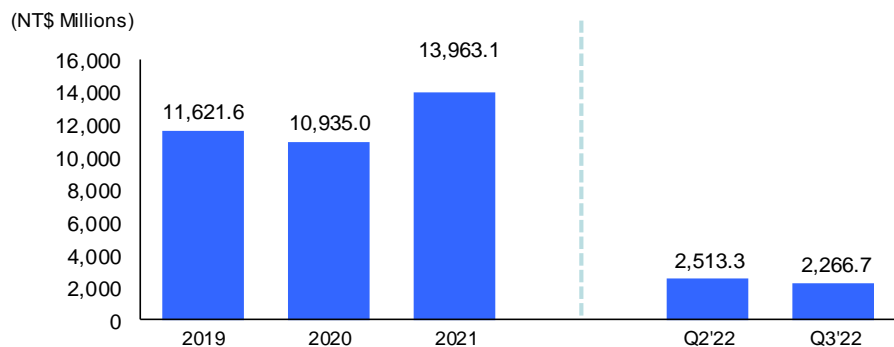

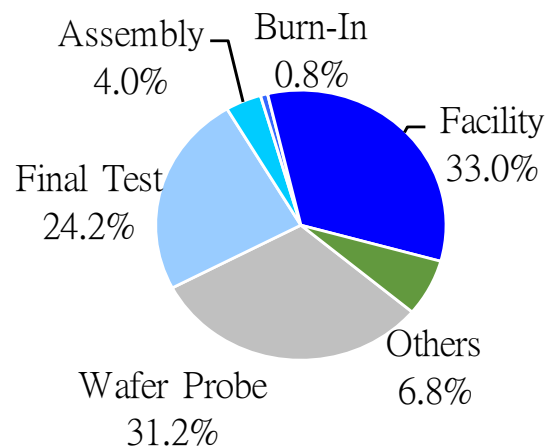
