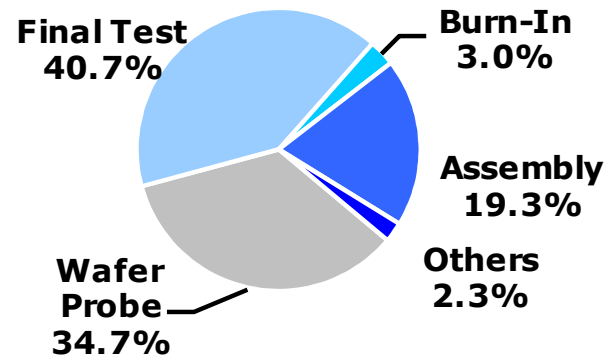

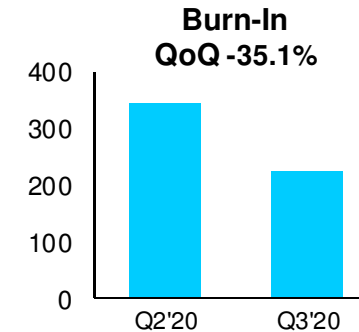
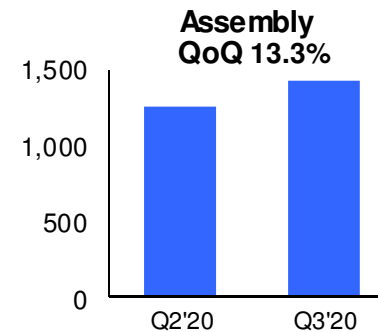
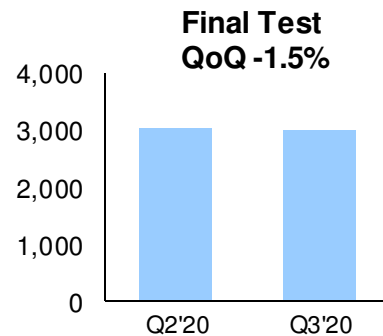
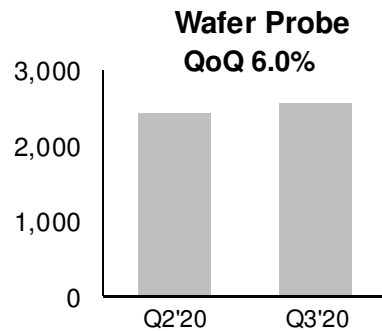
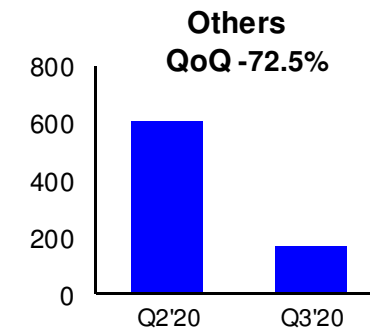


## Q3'20 Revenue Breakdown By Process (unaudited)

### By Process



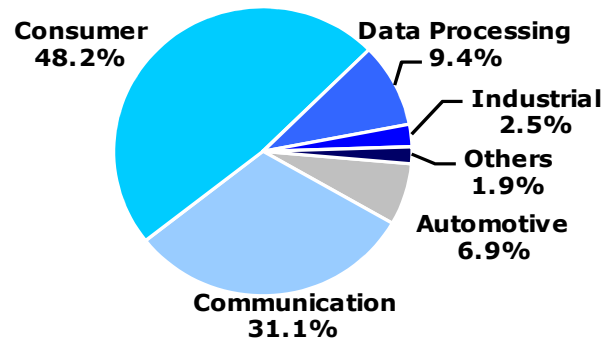

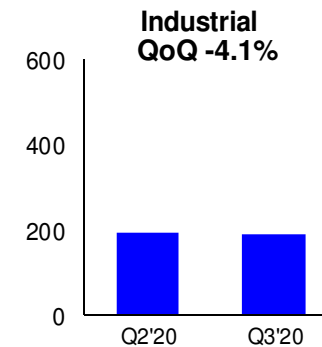
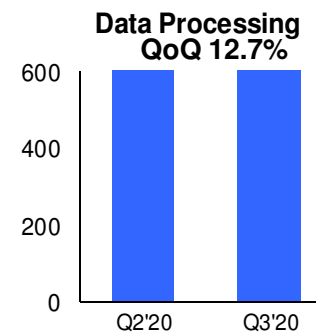
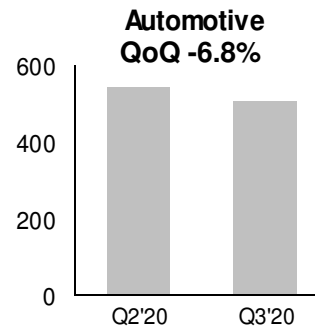
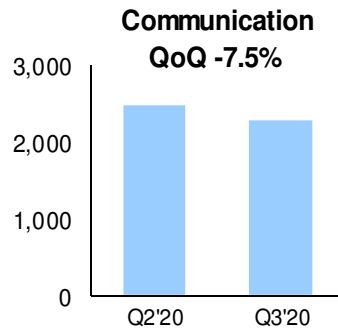
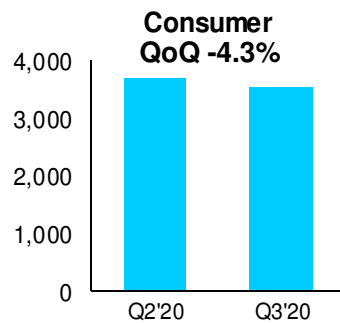
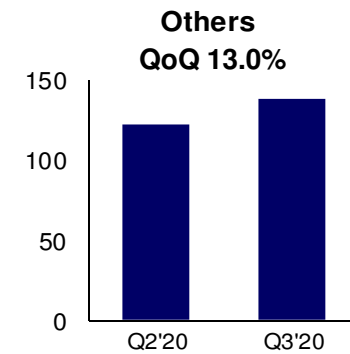


## Q3'20 Revenue Breakdown By Applications (unaudited)

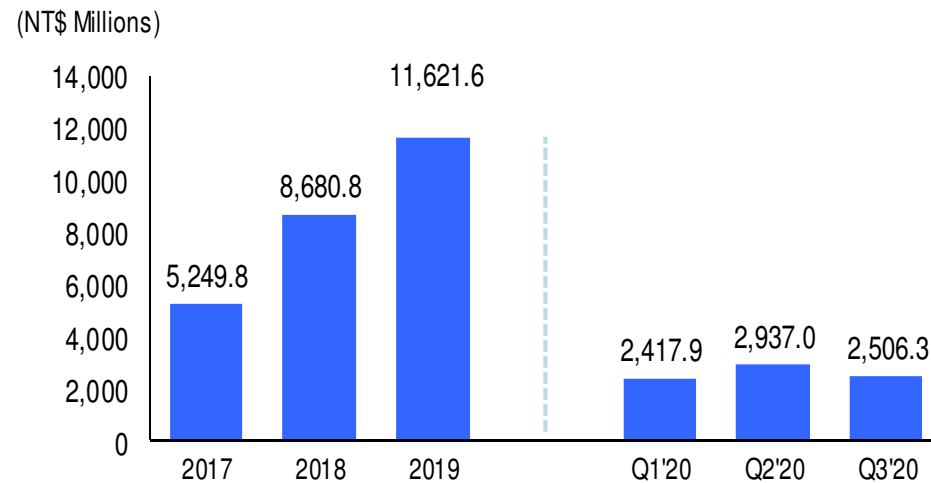

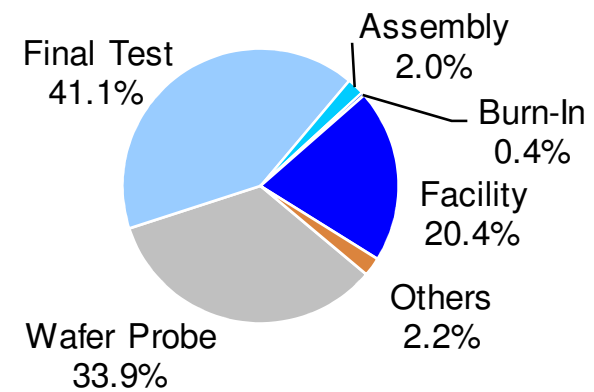
